The Task Force meets every two months. The next meeting is scheduled for February 26, 2018 in Conference Room 312 at the Capitol. • Would the legislature consider appropriating monies for an independent group to conduct a thorough needs assessment? <u>Answer:</u> This is would be handled by the House Finance Chair, who is Representative Sylvia Luke. • How does the public become aware of mental health bills? <u>Answer:</u> The legislative website has information on all mental health bills. • What mental health bills are currently being reviewed or considered by the Health and Human Services Committee? <u>Answer:</u> Representative Mizuno's office handles these bills, and information on them are on the legislative website. 5. Human Trafficking in Hawaii	<p>Ms. Lamb presented information on Human Trafficking in Hawaii. She explained the differences in terminology: Commercial Sexual Exploitation of Children (CSEC), refers to a range of crimes and activities involving sexual abuse or exploitation of a child for the financial benefit of any person or in exchange for anything of value (monetary and non-monetary benefits: protection, clothing, shelter, food, etc.) given or received by any person.</p> <p>Sex Trafficking is the recruitment, harboring, transportation, provision, obtaining, patronizing, or soliciting of a person for the purposes of a commercial sex act by force, fraud, or coercion, to perform such an act. Sex trafficking involves all genders from adults to children, from upper middle school to high school, and children under the age of 18.</p> <p>Ms. Lamb also explained that the Susannah Wesley Community Center (SWCC) has been providing case management services to labor and sex trafficking victims since 2007. Clients are both adults and minors and are from domestic and international areas. Further, the SWCC created the Trafficking Victim Assistance Program to provide:</p>	For information, only.	V. Lamb
