4. Human Trafficking in Hawaii – Mandatory Reporting	Ms. Florence Calderon of the Child and Welfare Services Department, briefed the Council on Human Trafficking in Hawaii and Mandated Reporting. She shared the "Confidential Mandated Checklist" form (approved but pending distribution) and an Information Sheet on Reporting Hotlines, in effect since December 6, 2017. She also shared a Department of Human Services (DHS) Guide for Mandated Reporters. This form will be made available after internal processes are completed.  Ms. Calderon discussed the ongoing concerns still faced in Hawaii and nationally, with finding longer placements for identified minor victims of human trafficking. She reported that Hale Kipa provides a 30-day placement at their assessment center.  Ms. Calderon reported that the Child Welfare Services staff will avail themselves to conduct mandated reporter trainings for providers and other stakeholders. The trainings are approximately 2-1/2 hours long, and DHS has been reaching out to public schools.
