IV. Child and Adolescent Mental Health Division (CAMHD) Updates	<p>Dr. Stan Michels updated the Council on CAMHD's activities. He stated that:</p> <ul style="list-style-type: none"> • The First Episode Psychosis Program has moved into their offices, which is next to Ala Moana Shopping Center. • Workflow redesign and IT Project Progress. The Project is now in its 3rd development demonstration phase. Selected sites will trail the system in December with roll-out to CAMHD in January. Roll-out for bill and providers will be in the fall of 2019. • The Hawaii Interstate Youth Network of Care (HISYNC) meets the 1st Tuesday every month to discuss joint policy and programmatic interphases. • A Request for Information will be going to providers for a short-term Crisis Residential Home level of care. This program will be jointly financed and governed by CAMHD, the Child Welfare, and the Alcohol and Drug Abuse Division. • By having this level of care, it will take the pressure off the hospital level of care, and Medicaid will be billed for services. She noted the following:</p> <ul style="list-style-type: none"> • The Substance Abuse and Mental Health Services Administration's (SAMHSA) Technical Consultant, Melody Riefer, met with members of the PIG on August 15th and shared pointers on making the State Council website more user friendly. • SAMHSA's Technical Consultant, Carlos Mendez, also met telephonically with members of the PIG through several meetings. She stated that having a plan for that length of time will allow the Council to accomplish a lot more than an annual plan. She also proposed that a PIG should be selected and tasked to meet two or three times to develop a plan for strategic planning. Other ideas were to:</p> <ul style="list-style-type: none"> • Request technical assistance from SAMHSA; • Hire a consultant to work with the Council to develop a 3-5-year strategic plan; • Utilize a consultant for pro-bono to work with the Council on the strategic plan; and • Use the State Council Retreat to work on the strategic plan. <p>Dr. Dang made a motion to hire a consultant to advise the State Council on a 3-5-year strategic plan.
