	<ul> <li>Proposed structural organization of the AMHD includes personnel re-organization.</li> <li>The Crisis Line of Hawaii has a new name, improved performance, and changes in scope of operation.</li> <li>Rebuilding Community Programs – AMHD is working on a Long Term Care Project for a skilled nursing facility. This facility is proposed to be on the grounds of the Hawaii State Hospital (HSH).</li> <li>Secure Facility – The Division is investigating a secure facility model for individuals that are sent to HSH because of their legal status, but who do not need in-patient clinical supports.</li> <li>HSH Master Plan – Due to the high census at HSH, the Department of Health and the AMHD will be releasing the Master Plan for the hospital shortly. The first phase of the plan is to construct a secured forensic facility designed for approximately 144-inpatient beds.</li> <li>Hawaii Health Systems Corporation – The AMHD continues to work with the HHSC for inpatient units on Maui, Hawaii Island, and Kauai.</li> <li>Referrals and Court Evaluations – Due to resignations, increased volume of court evaluations, and expanded caseloads, the Courts &amp; Corrections Branch is in the process of hiring additional staff.</li> <li>Personnel – Jacob (Jake) McPherson was hired as the new Chief of Office of Consumer Affairs.</li> <li>Vacant Positions – The AMHD has authorization to fill all vacant positions. The Community Mental Health Centers are authorized to fill vacant positions as the re-organization proceeds. The HSH is authorized to fill vacant positions as the budget allows.</li> </ul>
