How can the Council Work with the Media to De- Stigmatize Mental Illness	<ul> <li>Mr. Rod Antone, former newspaper and television reporter, shared ideas on how the Council could work with media to destigmatize mental illness. Mr. Antone shared the following steps to work with the media:</li> <li>Explain the consequences of negative words/phrases used to describe mental health.</li> <li>Educate the media on mental health conditions.</li> <li>Give resources to journalists so that they can avoid making mistakes about mental health.</li> <li>Meet with each news organization in town, and share mental health educational materials with staff.</li> <li>Identify staff in each news organization, i.e. upper management, news director, publisher, managing editor, to share information about mental health.</li> <li>Develop a cheat sheet with appropriate words that describe mental health;</li> <li>Have materials or resources on mental health as a ready reference; and</li> <li>Ask how to get positive stories about mental health out in the media, perhaps a weekly spotlight in the news, both in print and on television.</li> <li>Work with reporters who have specific health reporting backgrounds/experiences to get the word out to the community about mental health.</li> <li>Partner with members of the media who already have ties to mental health literature, such as AARP Magazine, Kaiser, and HMSA newsletters.</li> <li>A long-term goal would be to have mental health talked about similarly to the way that physical disabilities are discussed – in open, frank, discussions without being judgmental.</li> <li>Mr. Antone shared a resource link on mental health that would be beneficial to Council members: https://www.psychiarty.org/newsroom/reporting-on-mental-health-conditions.</li> </ul>	For information, only.
