I. Call to Order and Roll Call

- Call to Order: Meeting convened at 9:07 a.m. by Chairperson Katherine Aumer.
- Roll Call: Conducted by Secretary Mary Pat Waterhouse. Quorum established with 11 members present (8 needed).

II. Announcements

- Meeting protocol: If technology fails and cannot be restored within 30 minutes, the meeting will recess and reconvene on September 16 at 9:00 a.m. using the same Zoom link.
- Suicide Prevention Awareness Month (September): Out of Darkness walks scheduled on O'ahu (Sept. 13), Hilo (Sept. 27), and Maui (Oct. 28).
- Membership Update: Chair Aumer announced Naomi Crozier's completion of eight years of service, expressed gratefulness for her dedication, and recognized her insights from a Native Hawaiian perspective. The Governor's office also announced that the housing sector seat will be filled out soon.
- Ex-Officio Clarification: Marian Tsuji remains the Council's ex-officio member. This is different from Dr. Courtenay Matsu becoming the State Mental Health Authority Commissioner.

III. Approval of Previous Meeting Minutes

- August 9, 2025, meeting minutes draft was approved subject to corrections in name spellings. Lea Dias moved to approve, Jon Fujii seconded, and the rest unanimously voted in favor of approving.
- June 10, 2025, meeting minutes draft was approved. M. Waterhouse moved to approve, Jackie Jackson seconded, and the rest unanimously voted in favor.

IV. Community Input

Marissa "Squirrel" Celeste shared her personal journey of recovery, describing how she overcame post-traumatic stress disorder (PTSD) and methamphetamine addiction. She shared that she has been clean for 22 years and credited her success to the support she received from the NAMI Diamond Head Clubhouse, United Self Help, and the use of Cognitive Behavioral Therapy (CBT) and Dialectical Behavior Therapy (DBT). She emphasized the importance of having culturally inclusive recovery pathways to ensure that all individuals can access support that resonates with their backgrounds and experiences.

Chairperson Aumer led in expressing deep appreciation for Marissa's sharing of her story of recovery and for her continued advocacy in the mental health community. Bud Wolf from United Self Help chimed in that United Self Help now offers six weekly support groups—three held online and three in person. He shared that more information can be found at unitedselfhelp.org and that the organization is recognized for its long-standing service and dedication to mental health advocacy.

V. Old Business

A. Presentations

1. From Crisis to Recovery – Health and Resilience After the Maui Wildfires

There was approval for a draft letter reaffirming the Council's prior action to support MauiWES's efforts to pursue grant and funding opportunities. Lea Dias moved to approve the letter, Jackie Jackson seconded the motion, and the Council unanimously approved.

There was approval for a draft thank you letter to. Dr. Juarez and Team. Forrest Wells moved to approve the letter. L. Dias seconded the motion, and the Council unanimously approved.

2. Hawaii Workplace Wellness & Quality of Life Survey" Results –

There was approval for a draft thank you letter to Dr. Barile and Team. L. Dias moved to approve the letter. F. Wells seconded the motion, and the Council unanimously approved.

3. "County Integrated Service Area Planning: Context, Insights and the Future" and "Rate Studies and their Impact"

There were no draft letters of thank you presented. This agenda item was tabled.

B. Presentation, Discussion and Recommendation Approved and Submitted Letter to SAMHSA Submitted Plan and Application FY26- FY27 Mental Health Block Grant Planning Chair Aumer presented the formal letter reaffirming Council's prior action to support Hawaii's FY26-FY27 Mental Health Block Grant Plan and Application. She confirmed that Hawaii submitted this requirement for MHBG funding to SAMHSA. The letter fulfills the Council's role in the FY26-FY27 Mental Health Block Grant Plan Application.

V. New Business

Carolyn Weygan-Hildebrand presented the Council discussion topics using a PowerPoint deck. Please refer to the attachment for details. After discussions, the key directions for action included:

- Membership: The status of each member will be provided including the link for applying again. The Council encouraged the use of staff and existing resources to announce vacancies and recruit applicants through social media and the Council website. For another Provider seat, a prescribing provider is preferred. The Council will continue prioritizing the filling of housing and service area board seats.
- In-Person Meeting: Scheduled for December 9, likely at an HIA Conference room, with optional training in the afternoon. The Council expressed interest in focusing on workforce issues, though there are concerns about covering the topic cohesively. It was noted that DHRD recently briefed the Legislature and should be invited to present to the Council in November or December.
 - Mary Pat Waterhouse moved that there be an in-person meeting. Heidi Ilyavi seconded. The members approved unanimously. A Permitted Interaction Group was recommended, with K. Aumer, L. Dias, and M.P. Waterhouse volunteering to participate.
 - C. Dang, as member of the public, suggested offering optional training on psychopharmacology. Staff will follow up on this recommendation.
- Advocacy for Individuals with SMI and SED: It will help the Council and other stakeholders if there was a report on supportive housing to better understand the needs of individuals with SMI and SED. It was clarified that in this context, supportive housing is used broadly to cover the continuum of housing needs. It includes group homes, Kauhale initiatives, and even Native Hawaiian perspectives.
- M.P. Waterhouse moved for the Council to become a potential client for internship and practicum programs and get support for completing a report on supportive housing. Christine Montague-Hicks seconded, and the motion was approved unanimously. Staff will explore suitable internship or practicum opportunities and explore what is viable.

 Statutory role in reviewing and commenting on a State Comprehensive Integrated Service Plan (SCISP). Carolyn Weygan-Hildebrand did not seek any action from the Council but explained the long road of deconstructing and reintroducing this mandated plan and planning process. She is hoping that the Council will finally get to review and comment on a SCISP, and not just an MHBG Plan, in 2026.





§334-11 Service area boards. (a) A service area board shall be established within the department of health for administrative purposes to advise each service area administrator. Each board shall consist of nine members appointed by the governor, who shall serve for terms to be determined by the governor. After the initial appointees, the governor shall fill each vacancy on a board by appointing a member from a list of four persons submitted by that board, except that, if the board is unable to achieve a quorum at two consecutive meetings called for the purpose of making such a list, the list may be provided by a group of at least seven service area consumers and nonproviders of mental health services. This group shall consist of all board members willing to participate in making the list and other area consumers and nonproviders of mental health services to be selected by the service area board chairperson and service area administrator. Any meeting called for the purpose of making the list shall be subject to part I of chapter 92.




"...a more persistent loss of housing capacity stems from a growing gap between the provider reimbursement rates paid and increased costs of leasing or renting properties, making it financially unfeasible for some providers to maintain their existing units. Referral data further underscore the challenge that there are very limited HUD-supported units for low income consumer who often rely only on general assistance for income. These units that have been supported by the federal Department of Housing and Urban Development (HUD) cap rent at 30% which is the most affordable housing for the very low-income consumers. Other options are market price-based options in a State with the highest cost of living, and thus leaving many of the most vulnerable individuals on referral lists without affordable housing options. --Excerpts MHBG FY26-27 Application-


SOME CONFUSION BEYOND MHBG PLANNING

Two years after the devastating Maui Wildfire Disaster, we join others in remembrance and reaffirm our commitment to supporting recovery and meeting community needs.

The Council commends the Maui Wildfire Exposure Study (MauiWES) for its rigorous, evidence-based work to understand the wildfires' health and social impacts. With accessible tools like the Maui dashboard and a service component that assesses survivors' needs and links them to mental health and related supports, MauiWES models trauma-informed best practices—ensuring survivors both contribute to research and receive timely help.

We support MauiWES' effort to seek grants and funding to continue research and services, but also urge stronger coordination with the Department of Health, its Certified Community Behavioral Health Clinics (CCBHCs), Qualified Public Health Clinics (QPHCs), the Department of Education, the Department of Human Services, and other partners. All have also been on the ground, helping survivors and the island community. By seeking and threading resources together, we can ensure all survivors and affected parties—not only research participants—benefit from a seamless network of care.

Recognizing the Department of Health's broad responsibilities, we see MauiWES as a complementary resource that can strengthen existing programs. Partnerships and diverse funding can amplify the collective impact of our public health and community systems.

As established in HRS 334.10, the State Council on Mental Health advises the Department of Health, Governor, and Legislature on statewide mental health care needs and resources. Our vision is a Hawai'i where people of all ages with mental health challenges can achieve recovery and live full lives in the community of their choice.
